## LLB (HONS) PROGRAMME, UNIVERSITY OF LONDON

Denning Law School offers the opportunity to aspiring lawyers to procure an internationally recognised and reputable undergraduate law degree awarded directly by the University of London after studying locally at DLS – which is one of the largest affiliated institutions of the University of London in Pakistan.

The programme includes all the courses needed to obtain a qualifying law degree that is recognised by legal professions around the world.

Students who take part in the programme acquire practical experience in dealing with complex and demanding situations that they are likely to encounter in their future careers.







# ELIGIBILITY CRITERIA

At Denning, we understand that there are various factors to consider when determining a student's suitability for the University of London programme.

Denning Law School offers multiple pathways to students to progress to the LLB (Hons) programme at the University of London. Students who have completed any of the following qualifications can apply:

- 1 **GCE A-Levels**
- 2 **Intermediate** (Higher Secondary School Certificate)
- 3 **Bachelor's Degree**
- 4 **Master's Degree**
- 5 **Any Other Qualifying Degree**

Your application will be evaluated by our admissions specialist, who will determine the pathway of study you are eligible for.



## STANDARD ENTRY

This pathway allows a student to complete the LLB degree of the University of London within a minimum of three years and maximum of six years. A student needs to complete twelve (12) courses for the award of degree.

This pathway is for the students who meet the General Entrance Requirements of the University of London.

## CertHE (Certificate Of Higher Education)

Denning Law School offers the CertHE programme as an alternative pathway for students who wish to enrol in the LLB (Hons) programme at the University of London but have either completed their Intermediate from a local education board in Pakistan or missed the required grades in their A-Levels.

It is a unique independent qualification that provides students the opportunity to complete the same modules, as taught in the 1<sup>st</sup> year of LLB (Hons), and progress to the 2<sup>nd</sup> year of the LLB programme.

## GRADUATE ENTRY ROUTE

Students, with a prior four-year undergraduate qualification in any discipline are welcome to apply for the LLB (Hons), the University of London programme offered at DLS. The pathway enables students to achieve an internationally recognised LLB (Hons) degree in minimum of two years.

## GRADUATE ENTRY ROUTE ELIGIBILITY CRITERIA

This course is for graduates with a proven academic track record and who wish to gain a qualification in law either for legal professional purposes or to advance their careers in the field of law.

The following are the entry requirements for the Graduate Entry Route:

The student must possess a four-year undergraduate degree in any discipline from an accredited University in Pakistan.

OR

4-year undergraduate degree from any local university in Pakistan

2-year bachelor's and 2-year master's degree from any local university in Pakistan

3-year bachelor's degree from any UK or foreign university

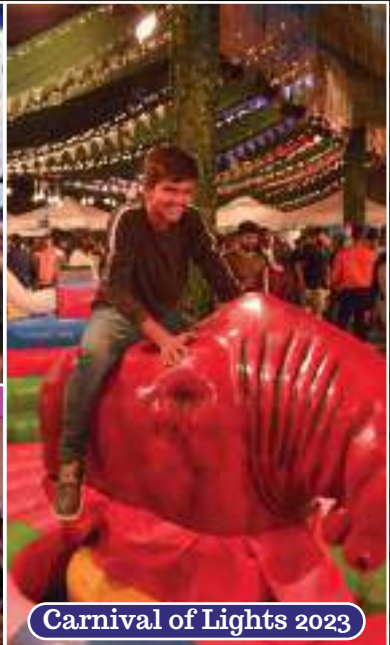

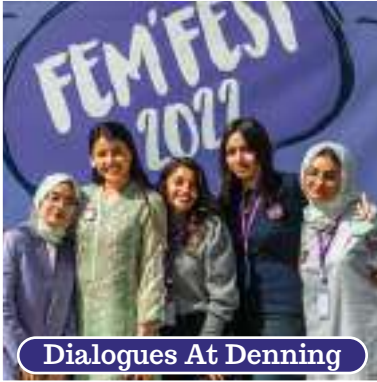

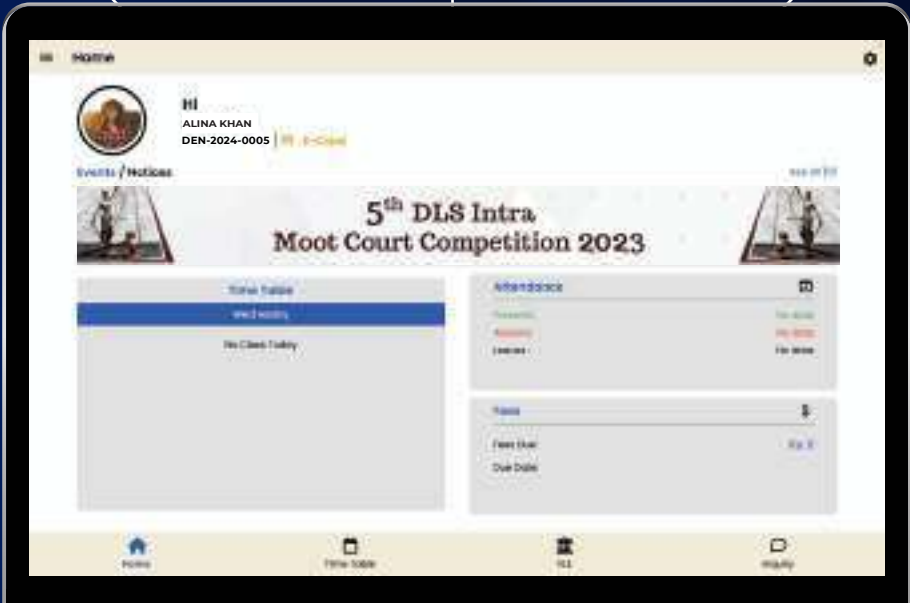
