## “Parachinar in Peril”

### Yet another Humanitarian Crisis

On November 21st, a convoy from Parachinar was ambushed, claiming the lives of 49 innocent civilians. Within days, the death toll had climbed into the hundreds. Parachinar, a picturesque valley at the heart of Kurram Agency, has been consumed by relentless sectarian and tribal violence, turning what was once a haven into a scene of devastation. This violence, however, is not purely sectarian; it is deeply rooted in historical, socio-economic, and political complexities. The crisis underscores the fragile writ of the state and the pervasive cynicism within society as it witnesses the bloodshed of its own people. Kurram Agency, of which Parachinar is the capital, is one of the seven tribal districts of the former Federally Administered Tribal Areas (FATA). The region is divided into Upper, Central, and Lower Kurram, with



Upper Kurram predominantly Shia and Central and Lower Kurram primarily Sunni. While sectarian identities are prominent, reducing the conflict to sectarianism alone oversimplifies a far more intricate and multifaceted crisis. Kurram's history of conflict traces back to the Anglo-Afghan War, where the Shia Turi tribe supported the British, while the Sunni tribes joined hands with Afghanistan. As a result, the Turi were rewarded with a larger share of land and resources, gaining significant influence in the region. For much of the subsequent period, the tribes coexisted in relative peace. However, the Soviet invasion of Afghanistan in the 1980s marked the beginning of widespread violence in the region. The influx of Afghan Mujahideen brought American weapons and militant ideologies, including a pronounced anti-Shia stance. This ignited sectarian violence in the 1980s, forcing the Shia population to migrate from Lower Kurram to Parachinar, which became the only Shia-majority region in the tribal belt. Compounding the tensions, many Afghan refugees settled on land owned by the Turi tribe, creating further disputes. In the post-9/11 era, the tribal region became a sanctuary for Taliban and Al-Qaeda fighters, escalating the violence. When the government attempted to evacuate Afghan refugees, the Taliban aided Sunni Saada tribes in seizing lands left behind by the refugees, intensifying tribal and sectarian conflict. The emergence of the Tehreek-e-Taliban Pakistan (TTP) further exacerbated the situation, with Shia mosques and places of worship becoming frequent targets of violence. More recently, the formation of the Islamic State Khorasan Province (ISKP), a regional faction of ISIS, has renewed brutal assaults on rival tribes and sects. In response, the Shia community has organized their own militant groups to defend themselves and retaliate. This cycle of attack and reprisal has created a perpetual state of unrest, claiming hundreds of lives with each escalation and leaving the region deeply scarred. According to Marx, economy dictates politics and social structure of a region. The resources beneath the land decide the ideology and structure above it. In Parachinar, the conflict has been driven by land disputes. In the most recent scenario, a 100 Kanal plot of land has become the bone of contention. Parachinar, often referred to as the "Parrot's Beak," lies just 100 kilometers from Kabul, making it highly susceptible to militant infiltration. The return of the Taliban in Afghanistan has further intensified the region's conflict. Beyond Afghanistan, the turmoil is also influenced by events in the Middle East. Shia volunteers joining the Zainabiyoun Brigade in Syria bring back not only a pan-Shia interpretation of Islam but also weaponry, fueling local tension. Compounding these challenges is the region's severe socio-economic underdevelopment. The literacy rate in the former FATA is among the lowest in Pakistan, standing at a mere 17%. Governance, until recently, was conducted under the Frontier Crimes Regulation (FCR), a repressive colonial-era system that ruled indirectly through political agents (PA) and tribal leaders. It was only after the 25th Amendment to the Constitution that the region was integrated into the mainstream administrative framework of Khyber Pakhtunkhwa (KPK). The consequences of this ongoing crisis have been devastating. In November 2024 alone, more than 130 lives were lost to violence. Persistent road blockages have isolated over 80,000 residents from the rest of Pakistan, forcing them to take an alternative route through Afghanistan, adding 15 hours to their journey. The Thal-Parachinar Road was blocked for two weeks in September and for 22 days in November, creating a dire situation reminiscent of the blockades in Gaza. The region remains trapped in a cycle of bloodshed, deprivation, and suffering, with no resolution in sight. Despite the dire situation in Parachinar, the fragile writ of the state and societal indifference remain deeply concerning. Under Article 9 of the Constitution, the state is obligated to protect its citizens, while Article 39 mandates the provision of socio-economic opportunities. As the sole entity with the legitimate monopoly over violence, the state must address this crisis as a priority. The conflict in Parachinar poses a significant threat not only to the region but also to the stability of the entire country. Yet, it has failed to receive the attention it urgently requires. The lack of response was starkly evident when the Chief Minister of Khyber Pakhtunkhwa (KPK) was seen attending a protest in Islamabad just days after the massacre. Meanwhile, both the media and public discourse were preoccupied with political turmoil in Islamabad, sidelining the horrors unfolding in Parachinar. It is imperative that the lives and well-being of people across all regions of the country be treated with equal importance. The conflict demands a comprehensive policy encompassing dispute resolution, equitable land distribution, and de-weaponization. Strengthening border security with Afghanistan is also critical to ensuring lasting peace in Parachinar. A new agreement, reached on January 1, 2025, offers a glimmer of hope for resolving the conflict. However, its success hinges entirely on the state's commitment to enforcement. Whether this accord will bring meaningful change or meet the same fate as previous, failed agreements remains to be seen.

## "Beyond the Silence"

### Gender-Based Violence in Pakistan

In 2024, the Global Gender Gap Report, published by the World Economic Forum, ranked Pakistan 145th out of 146 countries; this is a deeply concerning position for the Islamic Republic of Pakistan. The report assesses countries based on four key indicators: economic participation and opportunity, educational attainment, health and survival, and political empowerment. Collectively, these indicators highlight systemic issues that contribute to gender-based violence (GBV).

Gender-based violence remains a critical global concern, as emphasized by Amnesty International. In one of its reports, Amnesty International starkly describes the pervasive nature of such violence:

"Women in Asia and the Middle East are killed in the name of honor. Girls in West Africa undergo genital mutilation in the name of custom. Migrant and refugee women in Western Europe are attacked for not accepting the social mores of their host community. Young girls in southern Africa are raped and infected with HIV/AIDS because perpetrators believe that sex with virgins will cure them of their disease. And in the richest, most developed countries of the world, women are battered to death by their partners."

This chilling account underscores the universal and multifaceted nature of GBV, transcending geographic, cultural, and socioeconomic boundaries. The stark reality of our world today underscores the urgent need for a collective global effort to address and eradicate gender-based violence.

In Pakistan, individuals of different genders experience various forms of violence. Direct violence includes physical, sexual, psychological, and economic abuse. Structural violence, as defined by the UN Special Rapporteur, refers to "any form of structural inequality or institutional discrimination that maintains a woman in a subordinate position, whether physical or ideological, to other people within her family, household, or community." From acid attacks and rape to neglect of health concerns and domestic violence, women are systematically denied access to basic necessities, safe environments, education, and even the internet.

News of violence against women has become a disturbing routine in Pakistan. Stories such as Malala Yousafzai being shot for advocating education, Zainab being raped, Noor Muqaddam being brutally murdered, and 16-year-old Raheela Raheem being attacked with acid are just a few examples of an unending list of atrocities.



These acts of violence are a consequence of the deeply ingrained patriarchal norms that have roots in early Judeo-Christian history and remain culturally embedded in societal structures. They reflect a grim reality where women's rights and safety are persistently undermined.

Pakistan, however, is a signatory to numerous international commitments aimed at eliminating violence against women. These include the Universal Declaration of Human Rights, the Nairobi Forward-looking Strategies for the Advancement of Women, the International Conference on Population and Development (ICPD), the International Covenant on Economic, Social and Cultural Rights (ICESCR), the International Covenant on Civil and Political Rights (ICCPR), the Vienna Declaration, the Beijing Declaration, and the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW).

At the national level, both provincial and national assemblies have enacted various laws to ensure the safety and rights of women. Notable legislations include the constitutional safeguards for women, the Protection Against Harassment of Women at the Workplace Act, 2010, the Acid Control and Acid Crime Prevention Act, 2011, the Prevention of Anti-Women Practices Act, 2011, the Criminal Law (Amendment) (Offense of Rape) Act, 2016, the Criminal Law (Amendment) (Offences in the Name or Pretext of Honour) Act, 2016, the Anti-Honor Killing Act, 2016, and the Domestic Violence (Prevention and Protection) Act, 2020.

Despite this robust framework of legislation, the persistent issue lies in its lack of effective implementation. Laws that should protect women often fail to translate into meaningful action due to systemic inefficiencies, cultural barriers, and inadequate enforcement mechanisms. This gap between legislation and practice continues to undermine efforts to eradicate violence against women in Pakistan.

However, amidst the challenges, movements like the Aurat March, held annually on March 8th to mark International Women's Day, and the leading role of women in initiatives like the Rawadai March serve as beacons of hope in the fight against gender-based violence. These movements amplify voices calling for equality, justice, and an end to violence against women.

Many academic institutions are also contributing to this cause by fostering awareness and promoting gender equality. For instance, Denning Law School in Karachi organized a workshop on Women's and Children's Rights in Pakistan and celebrated Pink Day to raise awareness about women's health issues, including breast cancer.

Such initiatives reflect a growing societal commitment to addressing gender-based violence and advocating for women's rights. However, much remains to be done to ensure these efforts translate into tangible and lasting change.

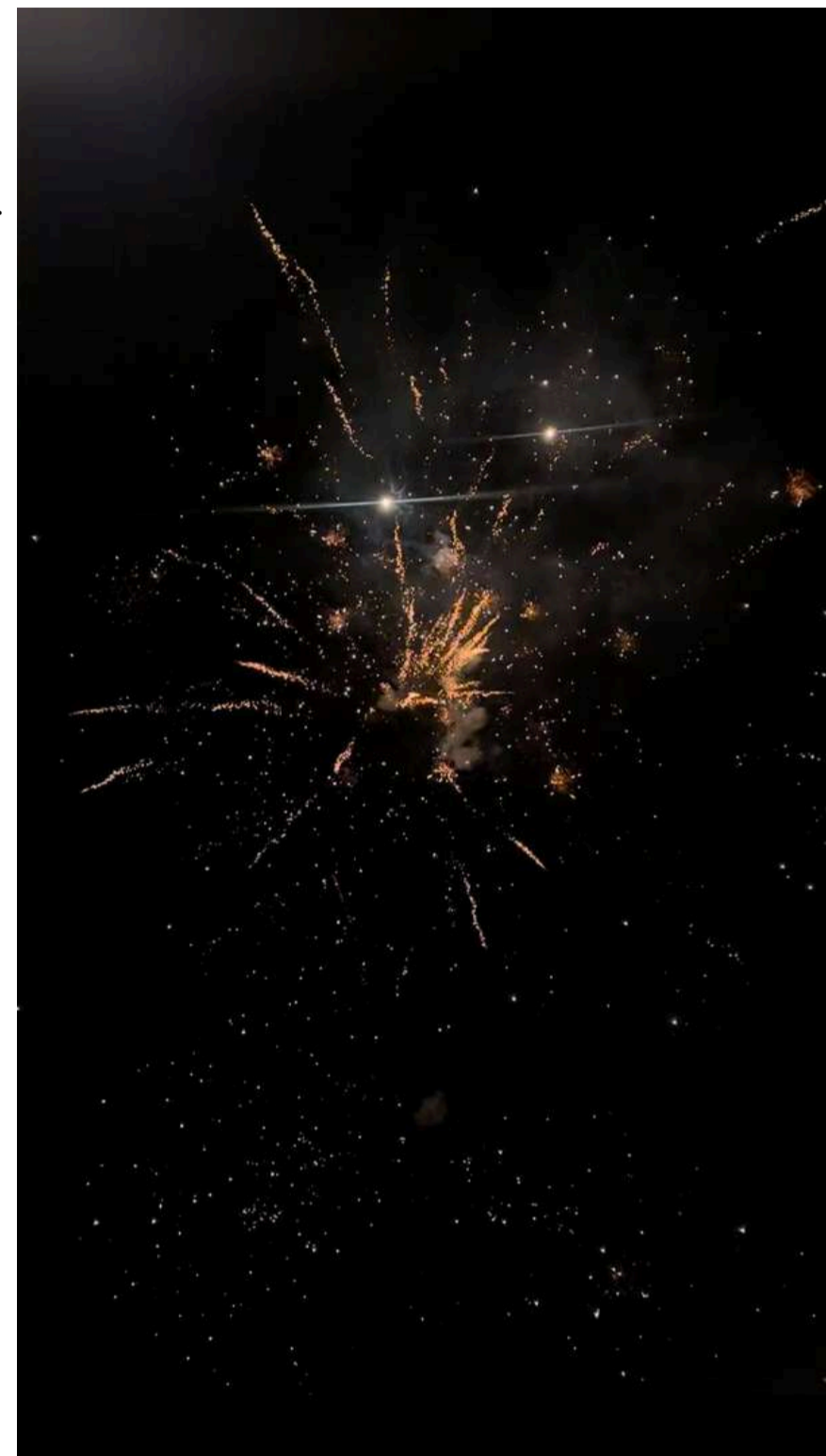
### Tazmeen Rashid: Self-Care Extraordinaire

When she heard about the Villisca Axe Murder House, one of the most infamous unsolved crimes in American history, she knew she had to see it. ### Do Your Final Moments Outweigh a Lifetime?

Death is an inevitable part of life and a reality none of us can escape. Hence, rather than viewing it as a looming threat, it is more fitting to embrace it as a natural phase of the life cycle. At some point of our lives, we do imagine ourselves on a deathbed, reflecting on memories, both good and bad, and departing this world as somewhat heroes of our own stories. However, life seldom unfolds in such theatrical manner.

The reality is often less poetic.

Many pass away due to cancer, strokes, or heart attacks. Strokes and heart attacks rarely allow for any contemplation, while cancer often clouds the mind with painkillers, leaving little room for coherent thought. The truth is that dwelling on how we'll spend our final days serves no real purpose and can rob us of the real joy of living in the present. Instead of fixating on the end, we should focus on making the most of the time we have now.

Daniel Kahneman, the renowned author of *Thinking, Fast and Slow*, highlights a fascinating flaw in how the human mind processes and recalls experiences. According to him, we don't remember events in their entirety, instead only retain mere snapshots of an instance, which primarily includes the peak moments and the eventual ending. For instance, if you embark on a four-week vacation, your memory is likely to condense the experience to just the highlights of a single week, leaving the rest a blur.

Moreover, Rolf Dobelli, author of *The Art of the Good Life*, presented a thought-provoking scenario to university students in the US. He described two women, Anna and Berta, who never married or had children but lived fulfilling lives. Anna died suddenly at 30, while Berta passed away at 35, with her final years marked by undesirable circumstances. When asked who had the more fulfilling life, most students chose Anna, emphasizing her happy final years.

This outcome illustrates the peak-end rule, where the significance of an experience is judged primarily by its peak moments and its conclusion. Researchers dubbed this phenomenon the James Dean Effect, referencing the actor who died at 24, during the height of his career. Had Dean lived longer and faced a decline, public perception of his legacy might have been less idealized, much like the comparison between Anna and Berta.



In essence, a person's reasoning and readings can be flawed in many ways; it is their very nature to overlook certain parts of their lives when drawing conclusions. This tendency is harmless in hypothetical scenarios like Anna and Berta's, but in real life, the narrative becomes more personal and profound. As people age, the magnitude of their happiness and accomplishments may seem to diminish, overshadowed by the inevitable afflictions of aging.

While a rational mind might strive not to let such hardships cloud the judgment of an entire life, it's a nearly impossible feat.

However, Dobelli offers a poignant perspective: it's far better to live a rich and fulfilling life, even if the final chapters are less than ideal, than to have no life at all. Aging and death are simply the costs of experiencing a remarkable existence, much like paying a premium for a Michelin-starred meal rather than settling for a plain cheeseburger. Life's value lies in savouring its fullness, regardless of how it concludes.
