





The Denning Alumni Network is guided by a robust governance model designed to promote inclusivity, representation, and effective decision-making.


- Patron-in-Chief: The CEO of Denning, serving as the guiding force behind the network.



### Honda and Nissan's \$54 Billion Merger Honda and Nissan will create a new joint holding company through a joint share transfer, which will some as the parent entity for both

## A historic comeback or a desperate gamble to stay afloat in the electric age?"

Honda and Nissan have unveiled plans for a historic \$54 billion merger, with Mitsubishi considering joining by January 2025, which could raise the deal's value to \$58 billion. If finalized, this merger will create the world's third-largest automaker, trailing only Toyota and Volkswagen, and mark the largest automotive merger in Japan's history. The deal is set to conclude by August 2026, and this strategic partnership is driven by the need to counter the growing dominance of Chinese automakers in the electric vehicle (EV) and autonomous driving markets. Honda CEO Toshihiro Mibe stressed the urgency of strengthening their competitive edge by 2030. The global EV market is anticipated to expand by nearly 30% in 2024, while the autonomous vehicle market is projected to reach \$448.6 billion by 2035.

The merger aims to leverage the strengths of both companies to optimize operations and reinforce market standing. By standardizing vehicle platforms, Honda and Nissan plan to enhance efficiency, lower costs, and accelerate development across internal combustion, hybrid, plug-in hybrid, and electric models. This integration will refine products such as Honda's CR-V and Accord and Nissan's Pathfinder and Armada, catering to diverse customer needs globally. Their combined research and development efforts will focus on next-generation software-defined vehicles (SDVs), expected to reduce development costs by over 20% while advancing technological capabilities. These initiatives align with their goal of achieving more than \mathbb{X}3 trillion in annual operating profit.

Honda aims to leverage Nissan's underutilized factories and expertise in large SUVs to diversify and expand its product portfolio, while Nissan seeks financial stability after a turbulent period marked by a 90% decline in earnings last year, which led to significant layoffs. Nissan's challenges date back to the 2018 arrest of its former CEO, Carlos Ghosn, on charges of financial misconduct. The merger news has drawn criticism from Ghosn, who, in an interview with Bloomberg, described Nissan as being in "panic mode." He labeled the deal a "desperate move" and questioned the feasibility of synergies between the two automakers.

Despite Ghosn's skepticism, Honda's advanced hybrid technology presents a promising opportunity to be integrated into Nissan's larger vehicles, enabling both companies to capitalize on growth potential in the increasingly competitive hybrid and electric vehicle markets. This collaboration could enhance Nissan's market presence while driving innovation and operational efficiency.

Manufacturing efficiencies are also a priority, with plans to share production lines and optimize facilities to increase capacity utilization and cut fixed costs by 15% to 20%. Consolidated procurement operations will enable the companies to source shared components and collaborate more effectively with suppliers, potentially saving ¥500 billion annually. Additional cost reductions will come from integrating systems and standardizing operational processes, with back-office expenses expected to decrease by ¥200 billion each year.

Honda and Nissan will create a new joint holding company through a joint share transfer, which will serve as the parent entity for both automakers. This plan is subject to shareholder approval and regulatory clearances. The holding company will support and develop both brands while preserving their unique identities and market presence.

The joint holding company is set to list on the Prime Market of the Tokyo Stock Exchange (TSE) by August 2026. Once listed, Honda and Nissan will become wholly owned subsidiaries and will be delisted from the TSE. Shareholders of Honda and Nissan will receive equivalent shares in the holding company, which will remain tradable on the TSE. All listing and delisting dates will comply with TSE regulations.

#### **Business Integration Timeline**

- December 23, 2024: Board of Directors' resolution and signing of the Memorandum of Understanding (MOU).
- June 2025: Execution of the definitive agreement, including the share transfer plan.
- April 2026: Extraordinary shareholders' meetings to approve the share transfer.
- End of July to August 2026: Delisting of Honda and Nissan from the TSE.
- August 2026: Share transfer takes effect, and the joint holding company is listed on the TSE.

Note: The timeline is tentative and may change due to procedural or regulatory factors. Any changes will be promptly announced.

Honda will have significant influence over the management of the joint holding company, nominating the majority of both internal and external directors. The President and Representative Director, or the President and Representative Executive Officer, will also be selected from Honda's nominees. While the Honda-Nissan merger offers significant opportunities, several challenges loom over its successful execution. Nissan's history of leadership scandals and financial setbacks raises questions about its long-term stability. Additionally, the potential for shifts in U.S. tariff policies under Donald Trump could further complicate manufacturing operations and inflate production costs, creating additional hurdles for both companies. Mitsubishi's potential involvement in the merger introduces an additional layer of uncertainty. While the brand could gain access to an expanded distribution network, there's a real risk that it may lose its distinct identity in the process. While models like the Outlander have seen modest success, other offerings, such as the Eclipse and Mirage, have faced criticism, limiting the brand's appeal. f Mitsubishi joins the merger, its commercial vehicle lineup, particularly in the U.S., could be at risk of discontinuation. This could further complicate its integration into the broader strategic goals of the merger, especially if the company's weaker models are phased out in favor of more competitive options from Honda or Nissan. These concerns highlight the delicate balance required to ensure the merger delivers its promised benefits while navigating these challenges.

## "NOT A SNOWBALL'S CHANCE IN HELL"

#### Trudeau's rejection of the Trump's 51st State Fantasy

Canadian Prime Minister Justin Trudeau has unequivocally dismissed former U.S. President Donald Trump's suggestion that Canada might become the 51st state of the United States. In response to Trump's provocative remarks, Trudeau reaffirmed Canada's sovereignty and the pride Canadians take in their distinct national identity.

Trump, known for his bold and often contentious statements, recently revived the idea of reshaping North America's borders, even suggesting that Canada could be annexed by the United States. Speaking at a press conference in Florida, Trump referred to the U.S.-Canada border as an "artificially drawn line" and argued that eliminating it could enhance national security and economic cooperation. "Canada and the United States together would really be something," Trump declared, going as far as to refer to Trudeau as "Governor Trudeau," implying a hypothetical role as a U.S. state leader.

Trudeau swiftly and decisively rejected Trump's proposition. During interview on MSNBC's Inside with Jen Psaki, Trudeau stated, "It's not going to happen. Canadians are incredibly proud of being Canadian, and that pride defines us." He emphasized that the idea of Canada becoming part of the U.S. is entirely implausible, adding that there is "not a snowball's chance in hell" of such a scenario. On social media platform X (formerly Twitter), Trudeau posted, "Canada's sovereignty is non-negotiable. We are proud to stand tall as an independent nation."

Trump's remarks come amidst ongoing trade tensions between the two His administration countries. had previously threatened to impose a 25%



tariff on Canadian imports, a move that could significantly impact Canada's economy, which relies on the U.S. as its primary trading partner for 75% of its exports.

Trudeau expressed concern about the potential economic fallout, stating, "These tariffs would hurt not just Canadians but also Americans, who would face higher prices on goods like electricity and oil."

The idea of annexation faces overwhelming opposition in Canada. Canadian provinces are fiercely protective of their autonomy, with distinct cultural and political identities that resist the idea of integration into the U.S. system. For instance:

Quebec: The province's francophone identity and history of separatist movements make it particularly resistant to any suggestion of integration with the U.S.

Western Provinces: Regions like Alberta and Saskatchewan, rich in natural resources, often view federal oversight skeptically and would likely balk at the idea of submitting to Washington's authority.

Moreover, Canada's political landscape, characterized by a multiparty system and decentralized governance, stands in stark contrast to the

centralized federal power. Annexation would also raise significant cultural and legal challenges:

- Bilingualism: Canada's commitment to bilingualism, particularly the rights of francophones, would clash with the predominantly English-speaking U.S.
- Indigenous Canada's **Rights:** constitutionally enshrined rights for First Nations, Métis, and Inuit peoples could be jeopardized under U.S. governance, potentially sparking widespread resistance.

Trudeau highlighted that Canadians often define their national identity opposition to American culture, stating, "When asked what it means to be Canadian, many will simply say, 'We're not Americans."

This affable anti-Americanism, coupled with deep-seated sense independence, remains a unifying force for Canadians.

Political analysts argue that Trump's suggestion may be more about generating headlines than a serious policy proposal.

However, the notion underscores the complexities of U.S.-Canada relations, which are often shaped by economic interdependence and cultural differences. Incorporating Canada into the U.S. would not only disrupt existing political institutions but also risk alienating a populace deeply committed to its sovereignty.

Canada's sovereignty, cultural identity, and distinct political framework ensure that it will continue to stand apart as a proud and independent nation.
